

**Comunicazione sullo stato di attuazione del Programma di acquisto

Reggio Emilia, 4 novembre 2020 – Iren, facendo seguito a quanto comunicato il 12 maggio 2020 in merito all'avvio del programma di acquisto di azioni proprie autorizzato dall'Assemblea degli Azionisti del 29 aprile 2020, rende noto di aver acquistato nella settimana dal 26 al 30 ottobre 2020, n. 1.500.343 azioni ordinarie al prezzo medio unitario di euro 2,0108, per un controvalore complessivo di euro 3.016.943,81.
