

**Comunicazione sullo stato di attuazione del Programma di acquisto

Reggio Emilia, 8 febbraio 2021 – Iren, facendo seguito a quanto comunicato il 20 novembre 2020 in merito all'avvio del programma di acquisto di azioni proprie autorizzato dall'Assemblea degli Azionisti del 29 aprile 2020, rende noto di aver acquistato nella settimana dal 1 al 5 febbraio 2021, n. 496.653 azioni ordinarie al prezzo medio unitario di 2,0617 euro, per un controvalore complessivo di 1.023.928,27 euro.
